Programs requesting to receive reimbursement for a COVID-related closure for longer than three (3) days must notify EEC by emailing the Regional Director within 24 hours of the anticipated closure to report on the reason for the request and anticipated dates of closure.

Application Fees
EEC is deferring licensing fees for Fiscal Year 2023. If you are submitting a licensing transaction, you do not need to mail in a payment at this time.
