Permission to share information about your case

Dear **Customer Name**,

You asked the Department of Revenue (DOR) to share information about your child support cases with someone else. Before we do that, we need to get your permission in writing. If you want someone else (like a family member) to get information and/or documents about your child support case, you must fill out the form on the next page. When you sign the form that means we can talk to that person about all the child support cases you have with us. The form lets us give that person the same information that we would give you. Once we get your form, we will take about 10 days to process it. We will send you a letter saying that we got the form.

How will the person be able to get information about my case?

We will speak with the person over the phone or send email. We will not give that person access to your cases on the interactive case manager on our website. When the other person calls or emails us, we will ask for:

- The other person's name, address and phone number
- Your full name, address, phone number, PIN or Social Security number, and date of birth

How long does the permission last?

2 years. If you change your mind before then, you can write to us any time and we will stop giving the other person information about your case.

What if I want to give information to my lawyer?

You don't need to send this form. Your lawyer can send us a letter on office letterhead with your name, address, and Social Security number, telling us that he or she represents you in your child support case. We can then talk to or send documents to your lawyer about your case.
