TRAVEL TIME

Time is computed from the time vehicle and helpers report at the original point of loading until the completion of unloading the last load at final destination, less time spent for meals or vehicle breakdown, plus an added charge for each vehicle and all helpers used, to cover running time which shall not be assessed more than once during any one day to the same shipper for the same vehicle as stated below:

UP TO AND INCLUDING 10 MILES-----ADD ½ HOUR

EACH ADDED 10 MILES OR FRACTION THEREOF-----ADD ½ HOUR

DEFINITION - The term "Household Goods and Furniture" as used in this tariff means: The transportation of furniture and household goods in whole or in part incident to a move by a householder to or from a dwelling and a storage warehouse; or from one dwelling to another.

ESTIMATES/QUOTATIONS - Carrier cannot quote a firm price on a move from a residence or establishment to another if a public way has to be used by a vehicle. He may give a written estimate, but in doing so be qualified to estimate within twenty-five (25%) of the actual charges. The final charges to be assessed shall be in accordance with actual tariff rates.

## RULES & REGULATIONS FOR LOCAL MOVES

Thank-you for choosing Aviv Moving & Storage to service your moving needs. We strive to provide excellent customer service throughout your move. To assist us in making your move as effortless as possible, please review the following information:

- The final cost of your move will be charged hourly plus the amount of packing materials are used the day of pick-up.
- All payments for the move must be in the form of cash, money order, certified checks, Visa, Master card, AMEX, Discover or Diners Club Int. Please note that **personal checks will not be accepted.**
- It is the customer's responsibility to thoroughly inspect the moving truck at the conclusion of the move to ensure that no personal belongings are left behind.
- The customer will be charged for a minimum of 3 hours regardless of the actual time of move.

## INSURANCE VALUATION COVERAGE

Aviv Moving & Storage offers two options for valuation coverage pursuant to the order of our services for local moving. **Valuation coverage is not insurance**; it is a tariff level of carrier liability in the event of loss or damage of your goods during your move by Aviv Moving & Storage, Inc. Please carefully review the information below:

- **Option A – Limited Liability Basic Coverage**  
As a licensed common carrier in the State of Massachusetts we are required to provide a limited coverage at no additional charge to the customer. Under this option the maximum liability is \$0.60 per pound, per article, in the event of damage or loss. For example: if an article weighing 50lbs is damaged it is the carrier's responsibility to compensate the customer \$30.00 dollars. (50\*0.60)
- **Option B – Replacement Valuation Coverage with a deductible of \$250.00**  
Replacement value coverage gives customers the option to repair or replace their belongings in the event of damage or loss over \$250.00. This coverage includes an amount equal to the replacement value (for comparable size and construction) of damaged property minus depreciation. The shipper is responsible for the first \$250.00 dollars deductible for any claim. Aviv Moving & Storage will be responsible for remainder of cost for repairs and/or replacement. If the item cannot be replaced or repaired, Aviv Moving & Storage will pay for the actual cash value of the item(s) lost or damaged minus depreciation. The fee for this option is \$10.00 per \$1000 and the minimum amount for this option is \$50.00 for \$5000. *Customer must insure the total actual (depreciated) cash value of the entire shipment.*

## THE OPTIONAL COVERAGE CANNOT BE APPLIED TO THE FOLLOWING:

- Accounts, bill deeds, letters of credit, passports, documents, money, precious stones, jewelry, article board, antique (will be covered under basic liability as a regular furniture only), operating functionality of electronic devices and musical instruments or other similar valuables.
- Omissions made by the shipper such as neglecting to prepare for a timely shipment.
- Any item that is not packed or unpacked by Aviv Moving & Storage.

The customer will never get charge for traffic delays on the travel time charge and there will be a travel time cap for the time calculate at trip wizards as yahoo maps and similar + 20%.

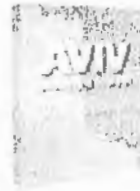
