- ✓ Carefully read the actual piece(s) of paper you are being asked to sign. Make sure that you first read the summary of the proposal that is printed at the top of, or on the other side of, each piece of paper you are signing. People gathering signatures may have placed a stack of petitions on a clipboard so that voters only read the petition on top, but are asked to sign additional petitions, which deal with separate issues, underneath.
- ✓ Look for a large capital letter or number with letter printed in the lower-right corner on both the front and back sides that identifies each ballot question. Pages bearing different large capital letters and/or numbers are for different ballot questions, and each contain a summary of the petition you are being asked to sign.
- ✓ If you believe you may have been deceived into signing a petition and want to ensure that your name is not certified as a legitimate signer of that petition, immediately contact your local registrars of voters in writing. State that you want to ensure you are not counted as a signer of a particular petition and identify that petition by its subject and the letter and/or number printed in the lower-right corner. State that, if your signature appears on that petition, you want your signature withdrawn and not certified. Include your name, address and telephone number and be sure to sign the letter in the same manner as you would have signed your signature on a petition. Deliver the letter to your local registrars of voters' office as soon as possible. This will maximize the chance that your signature will not be counted if it is on a petition you did not wish to sign.
