ITEM # 6ADDITIONAL CHARGES

If the carrier has to employ any extraordinary or additional services outside of its capabilities (renting cranes, bulldozers, specialized labor, etc.), the maximum charge will be exactly equal to those charges which have been levied by the outside organization on the tow carrier.

NOTESNOTE #1

Rates and charges shown under 8:00 a.m. - 5:00 p.m. will apply Monday through Friday but exclude all hours on Holidays.

NOTE #2

MILEAGE is based on round trip mileage from garage to return thereto. If the tow truck or ramp truck is dispatched from a point other than carrier's garage the mileage will be computed from the point where the disabled vehicle is to be towed or transported from to carrier's garage or to some other point where the carrier's vehicle has completed its assignment. This one way mileage will be doubled to reflect round trip mileage. The carrier will establish the mileage from the service vehicle odometer.

NOTE #3

Disposition of fractions (Mileage): omit fractions of less than 5/10, and increase fractions of 5/10 or more to the next whole figure.

NOTE #4

When more than one vehicle is transported on a ramp truck and the origin and destination is within the same city or town, the UP TO FIVE MILE charge will apply to each vehicle transported, regardless of distance.

NOTE #5

When more than one vehicle is transported on a ramp truck between cities or towns and a mileage charge would result in a charge greater than the UP TO FIVE MILE charge, the mileage will be computed according to the MILO MILEAGE GUIDE and then doubled to arrive at round trip mileage.

NOTE #6

When a ramp truck or car carry is used for the convenience of the carrier and the vehicle to be transported is in a suitable condition to be towed on either the front or rear

wheels, the rate applicable for a front or rear end lift will be assessed, EXCEPT when the owner requests or the manufacturer of the vehicle towed recommends that the vehicle be transported on a ramp truck.

NOTE #7

Charges for Wrecker Working While Standing and Waiting Time are in addition to the Tow Charge. Time is to be computed from time of arrival at scene until the disabled vehicle is in position to be towed and is to be calculated to the nearest quarter of an hour. The rate charged will be predicated on the Gross Vehicle Weight of the vehicle serviced as shown in ITEM #4.

If no tow charge is involved, time will be computed from the time the service vehicle is dispatched until it returns to carrier's garage and is to be calculated to the nearest quarter of an hour.

NOTE #8

Extra Labor time is to be computed from the time of leaving carrier's garage until return thereto and is to be calculated, subject to the minimum charge set forth in ITEM #5, as follows:

Up to and including 15 minutes	<u>15 minutes</u>
Over 15 minutes and including 30 minutes	<u>30 minutes</u>
Over 30 minutes and including 45 minutes	<u>45 minutes</u>
Over 45 minutes and including 1 hour	<u>1 hour</u>

NOTE #9

When a vehicle is locked and carrier is required to use a special tool or device to gain entry thereto a charge of \$5.00 will be charged. (If ITEM #4 is assessed, this service will be incorporated in the ITEM #4 charge).

NOTE #10

When it is necessary to disengage an automatic transmission on a disabled vehicle, an additional charge of \$5.00 will be assessed

on passenger cars. For trucks and buses the charge will be \$10.00. (If ITEM #4 is assessed, this service will be incorporated in the ITEM #20 charge).

NOTE #11 .

The customer is required to pay all toll charges.

DEFINITIONS

- #1 SERVICE VEHICLE means the vehicle used to tow or transport the disabled vehicle.

- #2. PASSENGER AUTOMOBILE means a motor vehicle capable of transporting up to eight passengers and a driver. A passenger automobile also includes an ambulance, hearse, and a flower car.

- #3. TRUCK means a motor vehicle used for the transportation of personal property.

- #4. BUS means a motor vehicle used for the transportation of passengers and having a seating capacity for nine or more passengers and a driver.

- #5. HOLIDAYS: The following are classified as holidays; New Year's Day, Washington's Birthday, Memorial Day, Independence Day, Labor Day, Columbus Day, Veteran's Day, Thanksgiving Day, and Christmas Day.

- #6. GROSS WEIGHT means the total weight, including the weight of the commodity on the vehicle plus the manufacturer's weight rating of the vehicle.

DEPARTMENT OF PUBLIC UTILITIES1. TRESPASS TOWING

THE FOLLOWING RATES REFER TO TOWING AND SUBSEQUENT STORAGE OF PASSENGER TYPE VEHICLES STANDING ON A PRIVATE WAY OR UPON IMPROVED OR ENCLOSED PROPERTY. CHAPTER 333 OF THE ACTS OF 1982 SPECIFIES THAT THE MAXIMUM TOWING CHARGE FOR THIS TYPE OF TOW SHALL NOT EXCEED THE MAXIMUM CHARGE ESTABLISHED BY THE D. P. U. PURSUANT TO G. L. C. 159B sec 6c. (FOR YOUR INFORMATION, A COPY OF THESE MAXIMUM RATES ARE ATTACHED.) THE ACT ALSO STATES THAT THE MAXIMUM STORAGE CHARGE "SHALL BE TWENTY DOLLARS PER DAY OR ANY PORTION THEREOF, WITH A MINIMUM CHARGE OF TEN DOLLARS."

SNOW TOWING

THE FOLLOWING RATES REFER TO THE TOWING & SUBSEQUENT STORAGE OF MOTOR VEHICLES FOR SNOW REMOVAL WHEN ORDERED BY POLICE OR OTHER PUBLIC AUTHORITY. CHAPTER 333 OF THE ACTS OF 1982 SETS A MAXIMUM TOWING CHARGE OF TWENTY FIVE DOLLARS & A MAXIMUM STORAGE CHARGE OF TEN DOLLARS FOR ANY TWENTY-FOUR HOUR PERIOD AND FIVE DOLLARS FOR ANY LESSER PERIOD.

TOWING CHARGE PER VEHICLE

TOWER'S REGULAR RATES ON FILE WITH THE DEPARTMENT SHALL APPLY UP TO THE MAXIMUM ALLOWED.

STORAGE CHARGES
