## **Observations and Recommendations**

- 1. The inmate population was 306 at the time of inspection.
- 2. At the time of inspection:
  - a. The Department recommended that all showers be identified with a numbering system. This will assist the Department and correctional employees to better recognize where issues exist; and
  - b. The Department observed that the hot water temperature in Pod B takes an excessive amount of time to come within compliance. Inmates complained that all sinks and showers must be run for a long period of time before water reaches minimum requirements. The Department recommends looking into this matter further so that hot water is achieved within a more appropriate time frame.
- 3. Hot water temperature range for handwash sinks is 110°F to 130°F.
- 4. Hot water temperature range for showers is 100°F to 112°F.

This facility does not comply with the Department's Regulations cited above. In accordance with 105 CMR 451.404, please submit a plan of correction within 10 working days of receipt of this notice, indicating the specific corrective steps to be taken, a timetable for such steps, and the date by which correction will be achieved. The plan should be signed by the Superintendent or Administrator and submitted to my attention, at the address listed above.
