OF DISMISSAL OF TAXPAYER/VOTER PETITION


IN RE: PETITION OF 25 TAXPAYERS OF BARNSTABLE REGARDING TRANSFER OF  
LICENSE TO HYANNIS WINE & SPIRITS, LLC

On or about January 19, 2016, at least twenty-five taxpayers/voters of the Town of Barnstable filed a Taxpayer/Voter Petition pursuant to M.G.L. c. 138, § 67, appealing the Town of Barnstable's approval of the transfer of a § 15 all alcohol license from Cotuit Grocery Co., Inc. to Hyannis Wine & Spirits, Inc., d/b/a Kappy's Fine Wine & Spirits.


The Investigative Unit of the Alcoholic Beverages Control Commission ("Commission") reviewed the transfer application along with the Taxpayer/Voter Petition. Upon review, the Investigative Unit failed to substantiate any of the claims raised in the petition and recommended approval of the transfer application on February 2, 2016. The Commission finds no basis to disapprove the decision of the Town of Barnstable in granting this license transfer. Accordingly, pursuant to the Commission's decision in Shree Hari Ji, Corp., d/b/a Whitney's Beverage Shop, North Adams (ABCC Decision October 16, 2015), the Commission hereby **DISMISSES** the Taxpayer/Voter Petition, and the Commission will take administrative action on the application.
