ORDER

On January 29, 2025, the Appellant, Lawrence Bateman (Appellant), a firefighter in the Town of Winchester (Town)'s Fire Department (WFD), filed a bypass appeal with the Civil Service Commission (Commission), contesting the Town's decision to bypass him for temporary promotional appointment to fire lieutenant in October 2023. That appeal was docketed under

Docket Number G2-25-032 and a remote pre-hearing was held by the Commission on April 8,

2025. 1

On April 3, 2025, prior to the above-referenced pre-hearing conference, the Appellant

filed a second appeal with the Commission, contesting the Town's decision to bypass him for

permanent promotional appointment to fire lieutenant on March 31, 2025.

Solely as it relates to the appeal docketed under G2-25-032 (the temporary promotional

appointment), the parties have jointly agreed to resolve this matter with the following order by

the Commission:

• Forthwith, and on an ongoing basis, the Town shall comply with all civil service law and

rules, including the requirement that candidates bypassed for appointment receive a

written notice of bypass reasons before any appointment becomes effective.

Nothing in this order or disposition shall be construed as limiting the Appellant's ability to

raise any relevant arguments as part of his other pending bypass appeal (the permanent

promotion) docketed under G2-25-090, for which a full hearing has been scheduled. With the

issuance of this order, the appeal docketed under G2-25-032 is closed.

Officer may have overlooked in deciding the case. A motion for reconsideration <u>does not</u> toll the statutorily prescribed thirty-day time limit for seeking judicial review of this Commission order or decision.

Under the provisions of G.L c. 31, § 44, any party aggrieved by this Commission order or decision may initiate proceedings for judicial review under G.L. c. 30A, § 14 in the superior court within thirty (30) days after receipt of this order or decision. Commencement of such proceeding shall not, unless specifically ordered by the court, operate as a stay of this Commission order or decision. After initiating proceedings for judicial review in Superior Court, the plaintiff, or his / her attorney, is required to serve a copy of the summons and complaint upon the Boston office of the Attorney General of the Commonwealth, with a copy to the Civil Service Commission, in the time and in the manner prescribed by Mass. R. Civ. P. 4(d).
