Bureau of Pipefitters, Sprinkler Fitters and Refrigeration Technicians Testimony to the Board

I comment today on the need for the Board to work on some clarifying language as it pertains to the licensing of Apprentice Refrigeration Technicians. It appears that in Board documentation the apprentices are getting sent different messages.

This is the board's website that states: The applicant: "Must provide proof that you are registered with your company with the Department of Labor and Industry"

Documentation from employer that you have worked not less than 6,000 hours in Massachusetts as a refrigeration apprentice or trainee

Documentation from employer that you have worked not less than 4,000 hours in Massachusetts as a refrigeration apprentice or trainee.

Documentation from employer that you have worked not less than 2,000 hours in Massachusetts as a refrigeration apprentice or trainee.

The question remains. Which is it? Why does an apprentice need to have to have dual apprenticeships one with the Department of Public Safety and One with the Department of Labor and Industry? Can they be a "trainee" What is the definition of trainee in the regulations? Is there one, I could not find it.

The Apprentice Licensure by the Department of Public Safety is not in question here. I think everyone agrees to that point. The burden of requiring the apprentice and his employing company to be registered with the Department of Labor and Industry is, in my opinion, a bit excessive and should be eliminated from the regulation as it causes a hardship on all concerned. It changes the apprentice ratio to journeymen as well as adds additional obstacles to a student who may have completed a 2000 hour course at an approved Chapter 74 School.

If we look at this requirement for an education and training point of view. There are roughly twenty three Chapter 74 vocational schools that offer an HVACR program. Of that 19 of them are regional school systems that represent roughly 180 cities and towns in the Commonwealth and there are three municipal vocational schools that represent an additional 3 cities. On average at any given time there are 1104 students at varying phases in the HVACR education cycle.

If we look just at Worcester County. There are five vocational schools representing 32 cities and towns with over 240 HVACR Students in the programs and yet there are only 3 approved Refrigeration Sponsors with the Department of Labor. **Exhibit # 3 (attached)** Of these three one is a Labor Union another is Fitchburg State University and the last is a small contractor in Sutton Massachusetts. I ask, how many apprentices can these three entities hire out of the 240 students we produce in Worcester County? Maybe one or two a year. What about the other 238 students that just spent the last four years learning the trade? How will they get their Refrigeration License?

The majority of our students are hired by small mom and pop contractors upon graduation. This is where they learn the ropes of the trade. These companies have usually less than twenty employees. There is no reason to require these companies to establish formal apprenticeship programs.

The only thing that the requirement of dual licensing accomplishes is to insure that the majority of Licensed Refrigeration Technicians are union affiliated. I don't believe that that is the intent of the Board but it is one of the unintended consequences of this regulation.
