Regular Meeting

- BBRS Regular Minutes Review/Vote approval of January 14, 2020 BBRS draft meeting minutes. Jen Hoyt believes the board did not limit the applicability of agenda item 4 to the 9th edition. Consensus of the group was to remove the 9th edition reference. On a MOTION by Jen Hoyt, seconded by Kerry Dietz, it was a unanimous vote to approve the January 14, 2020 meeting minutes for the Board of Building and Regulations and Standards as amended (EXHIBIT B).
- Quasi-Judicial Session Minutes Review/Vote approval of January 14, 2020 BBRS draft quasi-Judicial meeting minutes. Two typos identified by Cheryl Lavalley and Kerry Dietz. On a MOTION by Kerry Dietz, seconded by Jen Hoyt, it was a unanimous vote to approve the January 14, 2020, Quasi-Judicial meeting minutes for the Board of Building and Regulations and Standards as amended (EXHIBIT C).

- 3. **BOCC Minutes Review****Vote.** On a **MOTION** by Lisa Dave and seconded by Kerry Dietz, it was a unanimous vote to approve January 7, 2020, Building Official Certification Committee (BOCC) meeting minutes (**EXHIBIT D**).
- 4. Vote draft BCAB meeting minutes. Chairman Crowley confirmed with Attorney Charles Kilb the board can approve all 5 sets of meeting minutes with one motion. On a MOTION by Kerry Dietz and seconded by Lisa Davey, it was a unanimous vote to approve the 10/3/19, 10/22/19, 11/7/19, 11/19/19, and 12/5/19, Building Code Appeals Board (BCAB) meeting minutes (EXHIBIT E, F, G, H, and I).
- 5. Discuss 10th edition 2021 I-Codes adoption. Dan Walsh gave an overview of the process. He explained the Board had decided not to continue with the effort to consider the 2018 I-Codes (except for the 2018 IECC) and to look towards adopting the 0221 I-Codes for the 10th edition because the Advisory Committees have recommended little to no changes to the 2018 codes and the Mass. amendment provisions. When to begin this process is the question; the published 2021 I-Codes will not be available until the Fall of 2020. The ICC is willing to make available monograph versions (each code not yet correlated with the family of I-Codes) later this calendar year. Dorothy Mozzarella, Vice President, Government Relations for the International Code Council, spoke about the ICC code development process and said the ICC would make available any of the codes the Board will consider adopting when the codes become available. Ms. Mazzarella is not sure whether two challenges to the energy code and whether proper ICC Governmental persons participated in the vote, will delay the process but said ICC has a process in place to work through the issue.

Kerry Dietz asked Dorothy Mazzarella what areas of the code are changing the most? Ms. Mazzarella indicated the ICC staff currently working on the codes, and that information might be available soon.

Lisa Davey asked when the final versions would be available and wonders whether it would be better to start reviewing the codes now and have their report ready by the end of the calendar year.

Mike McDowell said we understand that the 2021 I-Codes are coming, and he thinks each Board member should start reviewing specific chapters to understand the changes and report back their findings. He also spoke about updating the codes is easier since the Board already looked at the 2018 I-Codes.

Kerry Dietz thinks we need to be ready, and we could start looking at the monograph versions. She also would like to have a blended version as opposed to front end amended codes. The Board had a general discussion about blended codes. Attorney Charles Kilb explained blended versions are different than the official releases, which are the codes filed with the Massachusetts Secretary of State's office, and these a compilation of Massachusetts Amendments with the ICC code.

Mike McDowell expressed interest in looking at the 1 and 2 family dwelling code. Kerry Dietz believes a board member be the point person with the advisory committees discussing portions of the codes. Chairman Crowley suggests staff reach out to each board member to understand which advisory committee they wish to be the point person. Jen Hoyt disagreed and thought each advisory committee was already created by the Board with specific tasks; however, Board members are welcome to attend any advisory committee meeting. She thinks staff should provide the Advisory Committee reports on the 2018 I-Codes.

John Nunnari, recognized by Chairman Crowley, asked the Board to engage the Mass. plumbing board about considering adopting the IPC. Chairman Crowley believes previous staff to the Board kept a list of plumbing issues, and these given to plumbing board staff.

6. Discuss\Vote providing comment FEMA Draft Policy Building Code & Floodplain Management. Dan Walsh explained FEMA has been developing new funding assistance to government entities for the administration and enforcement of building codes and floodplain management. Some eligible funding activities include inspection of structures, corrective actions, substantial damage estimates, and more. Governmental entities would have up to 180 days post a major flooding disaster declaration to submit for reimbursement. The Board has an opportunity to comment on the draft recovery policy before March 6, 2020. Chairman Crowley read comments from John Couture (EXHIBIT J). Chairman Crowley asked if FEMA excluded anything from the building envelope. Counsel Charles Kilb offered clarification for this topic. He suggested this is an opportunity for the Board to comment on the draft policy and not to comment on the FEMA regulations.

Kerry Dietz asked about the process (fees, etc.) and how this would work.

Dorothy Mozzarella spoke about ICC has been working on this effort within FEMA.

State District Building Inspector Supervisor Jeffery Putnam spoke about training which happened earlier this year.

No action taken.

- 7. **Discuss** 152 new Construction Supervisor Licenses (CSLs) issued in the month of January 2020. Staff reported everything is in order. No further action taken.
- 8. Adjourn. On a MOTION by Michael McDowell, seconded by Jen Hoyt it was unanimously voted to adjourn the regular meeting at about 11:50 am.
