5. **Discuss \Vote** 10th edition proposed amendments to the IRC

As a structural engineer, Lisa Davey was tasked to examine closely some issues regarding wind speed and seismic criteria in the 2021 IRC Chapter 3. The goal of which would be to help the board decide what language would be recommended for the 10th edition of the IRC. There was discussion regarding wind speed charts and how they would need to calculate them correctly, as well as the concern of wind born debris. Rich Crowley expressed concern that the language presented could affect the cost of construction in coastal communities especially when referring to high impact glass for windows. He suggested putting this section on hold for the time being. Lisa Davey expressed that she did not see that Massachusetts is any different from any other areas of the country as we still deal with tornados, northeasters, hurricanes and the like. Jen Hoyt stated that we need language that clarifies what Massachusetts requires. After a lengthy discussion, Greer Spatz Croxford redirected the conversation and asked if Massachusetts wants to accept the ICC language for wind born provisions.

A **Motion** was made by Lisa Davey and was **seconded** by Jen Hoyt to accept the original ICC language for wind provisions in the 2021 IRC. A Roll Call vote was held with the following votes: Michael McDowell voted NO, Rich Crowley voted NO, John Couture voted NO, Lisa Davey voted YES, Steve Fredrickson voted YES, Susan Gleason voted NO, Kent Vinson voted YES, Richard Baldacci voted YES, Jen Hoyt voted YES, Ian Finlayson voted YES, Kerry Dietz voted YES, **The Motion passes 7/4.**

Still discussing item #5, Lisa Davey pointed out to the board that most states need to follow seismic design requirements under the IRC. She also stated that there is a small part of the state that, under the IRC, would need to follow seismic design requirements and recommended using a map to identify those areas. David Holmes disagreed with the map and stated there should be a list of the affected communities. Jen Hoyt pointed out that we need to either accept the seismic language from the 2021 ICC or reject it.

A **Motion** was made by Lisa Davey to accept the ICC language on seismic design as it exists, and that Motion was **seconded** by Kent Vinson. A **Roll Call** Vote showed Michael McDowell voted NO, Rich Crowley NO, John Couture NO, Lisa Davey YES, Steve Frederickson YES, Susan Gleason NO, Kent Vinson YES, Richard Baldacci NO, Jen Hoyt YES, Ian Finlayson YES, Kerry Dietz YES. **Motion passed 6/5.** Lisa Davies said she would coordinate any discrepancies.

Regular Meeting Agenda (cont'd)

On behalf of the Department of Fire Services (DFS), Jen Hoyt presented some code change proposals to the 2021 IRC. Specifically, she defined what DFS would like to see regarding defining short-term rentals. Additionally, she spoke about garage separation and the acceptable materials to be used. She also spoke about the need for fire sprinklers R3.113.1 in town houses referring to NFPA 13D, NFPA 13 R, and NFPA 13.

R314.3 touched on the locations of smoke detectors specifically focusing on installations near cooking appliances, which can cause homeowners to become complacent when receiving many nuisance alarms. Finally, she addressed the issue that combination alarms smoke and CO detectors need to be interconnected and that UL has changed the criteria regarding the technology of detectors. No more ionization. John Couture stated that he would come up with some language to propose while trying to address the installation of detectors in close proximity to cooking areas. On another note, Jen stated she would address the issue of residential sprinklers at a future meeting.

Jen presented final recommendations from DFS for Section 328. Energy Storage systems were discussed as presenting concerns especially when the systems are inside of structures. There were also differences of opinions as to who had authority over energy storage systems.

9. **Request for Evaluation of Exam Scores**

A **Motion** was made by Rich Crowley to allow exam scores requests to be determined by DPL staff unless it was a medical reason that needed to be discussed privately. Motion was **seconded** by John Couture. A Roll Call vote was **unanimous**.

10. **Request for Medical Reinstatement** (Deliberations in Closed Session)

Staff reported a request from a construction supervisor to be reinstated without examination due to medical issues. Staff further notified the BBRS that if the individual's medical information had to be discussed, the BBRS should go into closed session. However, it was noted that this type of request is typically approved without extensive deliberation. The Chair opened the floor to motions. A **Motion** was made by Michael McDowell to approve the reinstatement without further deliberation and **seconded** by John Couture. A Roll call vote was **unanimous**.

11. **Other Matters not reasonably anticipated 48 hours in advance of the meeting.**

John Nunnari, representing the Massachusetts Chapter of the American Institute of Architects, requested that the BBRS address the recent ordinance passed in Quincy relative to restrictions on the use of certain building materials. The BBRS agreed to hear this at their April 12, 2022 meeting.

At 12:58 p.m., the chair noted that the only remaining agenda item was to take place in a closed session. The public was advised that the BBRS would enter closed session and then adjourn.

A **motion** was made by Mr. Finlayson to close the open session and enter into quasi-judicial session, **seconded** by Jen Hoyt. A Roll Call vote was taken, and the motion was approved **unanimously**.
