Summary of Case: Appellant is seeking relief from NFPA 13 Section 8.1.1 (7), 8.15.1.2,2,

with respect to new construction.

Jeffrey Clemons made a MOTION that was SECONDED by Jason Ferschke, to SUPPORT the Building Official who consulted with the Fire Official in that referenced standard NFPA 13 Section 8.1.1(7) & 8.15.1.2.2 do not apply in this case. The Motion was approved by unanimous vote.

Summary of Case: Appellant sought relief from 780 CMR 414.2.2, 414.2.4,

with respect to new construction.

Jacob Nunnemacher made a **MOTION** that was **SECONDED** by Jeffrey Clemons, to **GRANT** a variance to **780 CMR** 9th **Edition 414.2.2**, **414.2.4** conditioned on the following:

1) Increase in Sprinkler Protection up to an extra Hazard Group I. 2) Moving the egress corridors up to 1 hour rated serving the research labs. 3) Smoke detection throughout all research labs. 4) Laboratory fuel exhaust hoods in rooms exhausts on generator power. 5) Emergency voice Communication Fire Alarm System. All five (5) items as provided in the appellant's documentation. It is also noted that the Building Official is not opposed. The Motion was approved by unanimous vote.
