MINUTES:

MOTION made by Greg Dorrance to accept the minutes of the March 7, 2023 meeting. Seconded: Henry Vaillancourt. No further discussion, motion passes via roll call unanimously, 4-0.

EMPLOYEE REVIEW:

Superintendent Matton provided documents for review and comment. Discussion will continue at future meetings.

ELECTRIC VEHICLES CHARGING STATIONS:

Superintendent Matton provided an update on the process of requesting grant funding from National Grid or the state for installation of EV charging stations. The property owner can use a license electrician to increase service to the building including adding additional 40amp service. Superintendent Matton provided suggested equipment for overhead charging plugs to prevent permanent charging fixtures in the open concept garage.

MOTION made by Henry Vaillancourt to begin infrastructure electrical wiring with property owner for interior chargers. Seconded: Greg Dorrance. No further discussion, motion passes via roll call unanimously, 4-0.

SPRING AERIAL LARVICIDE UPDATE:

Entomologist Duval stated the spring aerial larvicide is scheduled to start this week using Plymouth County's airplane. The *Cq. perturbans* application by helicopter to the cattail marsh in Easton is planned for end of the month. Field technicians are using the new FieldSeeker larvicide program however there are significant offline issues. Mr. Duval and Superintendent Matton scheduled two outreach programs in Norton and New Bedford.


