**DECISION**

**BLUE FUJI BEDFORD INC. D/B/A BLUE FUJI  
200 THE GREAT ROAD, UNIT #1A-2B

Blue Fuji Bedford Inc. d/b/a Blue Fuji (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, October 1, 2019, regarding an alleged violation of 204 CMR 2.05 (2)- Permitting an illegality on the licensed premises, to wit: M.G.L. Ch.138 § 34- Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigator Di Cicco's Report.

The following documents are in evidence:

1. Investigator Di Cicco's Compliance Check Field Report;
2. Licensee Stipulation of Fact;
3. Copy of Application Approved 6/14/2016;
4. Copy of Receipt for Purchase of Alcohol.

There is one (1) audio recording of this hearing.

**FACTS**

1. On Monday, July 22, 2019, at approximately 5:45 p.m., Investigators Bolcome and Di Cicco ("Investigators") investigated the business of Blue Fuji Bedford Inc. d/b/a Blue Fuji.
2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a bottle of Bud Light beer for five dollars and eight cents (\$5.08). The underage operative was not asked for identification.
3. The Licensee has held a license under M.G.L. c. 138, § 12 since 2016 with no prior violations.

### CONCLUSION


Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2)- Permitting an illegality on the licensed premises, to wit: M.G.L. Ch.138 § 34- Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. The Commission issues a **WARNING**.
