Road North Reality LLC d/b/a Northside Convenience (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, October 1, 2019, regarding an alleged violation of 204 CMR 2.05 (2)- Permitting an illegality on the licensed premises, to wit: M.G.L. Ch.138 § 34- Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigator Bolcome's Report.

FACTS

1. On Monday, July 22, 2019, at approximately 6:18 p.m., Investigators Di Cicco and Bolcome ("Investigators") investigated the business of Road North Reality LLC d/b/a Northside Convenience.

- 2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a 12-ounce container of Coors Light beer for one dollar and fifty-five cents (\$1.55). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2008 with no prior violations.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2)- Permitting an illegality on the licensed premises, to wit: M.G.L. Ch.138 § 34- Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. The Commission issues a **WARNING**.
