## **DECISION**

43 LLC D/B/A COMELLA'S 43 LEONARD STREET BELMONT, MA 02478 LICENSE#: 0088-00020

VIOLATION DATE: 08/29/2017 HEARING DATE: 12/19/2017

43 LLC d/b/a Comella's (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, December 19, 2017, regarding an alleged violation of 204 CMR 2.05 (2) – Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Keefe's Report.

The following documents are in evidence:

- 1. Investigator Keefe's Compliance Check Field Report; and
- 2. Licensee's Stipulation of Facts.

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's record.

## **FACTS**

- 1. On Tuesday, August 29, 2017, at approximately 7:00 p.m., Investigators Keefe and Di Cicco ("Investigators") investigated the business 43 LLC d/b/a Comella's.
- 2. An underage operative, working with Investigators, was served by the Licensee an alcoholic beverage, a draft Bud Light beer. The underage operative was not asked for identification.

## CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. As the Licensee has had no prior violations, the Commission issues a **WARNING**.
