Call to Order: 1:08 p.m.:

- 1. Roll call.
- 2. Discussion and review of 524 CMR Sections 26.00: Certain Elevator Equipment Used as Motor Vehicle Parking. [Exhibits 1-2]

The board discussed 524 CMR Section 26.00: Certain Elevator Equipment Used as Motor Vehicle Parking – Stackers - including reviewing the draft version of the classification definitions and editing the wording to be more specific in multiple places including attendant definition, private garage definition, stacker system with no pass through allowed, public vs. private, and differentiating the words system vs. unit.

The discussion continued with questions on outside parking units and what restrictions should be imposed, if any, including the height of walls and enclosures, locking mechanisms of the pump units, and units not protected from the weather on an outside unit with public access and if attendants should be required, if the electrical and pump fall under the Building Code and if a pump unit should be in a separate protected area, if an outside private parking unit needs to be written in code.

Brian Ronan joined the meeting at 1:45 pm remotely via Teams.

David Gaudet left the meeting at 2:10 pm and returned at 2:14 pm

Mr. Morse provided Mr. Kelley with weather wording to be utilized in 524 CMR Section 26.04.2 and a discussion followed regarding the formatting and location of specific wording within the document. The conversation moved onto topics including spacing from the bottom of sprinklers without giving a specific number in case the code changes, operations within a specific amount of feet, not being near the platform, having a fixed spot (flexible or tarzan), constant pressure with no manipulation or fob, what or where the public notification of a shutdown notice implementation should be, safety padding on platforms and flashing lights or sound indicators when the system is moving.

The discussion concluded with Eric Morse indicating that he will put together a first draft for the next section, under the classification of the Semi-Automated Parking System, for discussion and review by the board at a future date.
