2. **8 Colonial Drive Westborough**  
**State IDs: 328-P-6 and 327-F-7**  
Petitioner is requesting a variance from 524 CMR 35:00 § 2.8.3.3 "Sprinklers shall not be permitted in power passenger or freight elevator hoistways pits, machine rooms or control spaces.", to allow the installation of sprinkler coverage in the elevator machine room.
3. **44 North Road, Bedford**  
**State ID: 24-P-163**  
Petitioner is requesting a variance from A17.1-1987,1989, 1996 § 211.3c(1)(c) – Firefighter Phase II Emergency In-Car Operation.
4. **26 Court Street, Boston**  
**State IDs: 1-P-3014, 1-P-3015, and 1-P-3016**  
Petitioner is requesting a variance from 524 CMR to keep the same three elevators out of service for an additional six months until June 6, 2023.
