# **Observations and Recommendations**

- 1. The inmate population was 169 at the time of inspection.
- 2. Hot water temperature range for showers is 100°F-112°F.
- 3. At the time of the inspection Housing Pod-F was not occupied.

This facility does not comply with the Department's Regulations cited above. In accordance with 105 CMR 451.404, please submit a plan of correction within 10 working days of receipt of this notice, indicating the specific corrective steps to be taken, a timetable for such steps, and the date by which correction will be achieved.
