Jatra Industries, Inc. dba Tedeschi Food Shops (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §15. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, October 2, 2012, regarding an alleged violation of 204 CMR 2.05(2), to wit: c.138, §34-Sale or Delivery of an alcoholic beverage to a person under twenty-one (21) years of age. - 2. An underage operative working with investigators purchased an alcoholic beverage, a can of Budweiser beer for one dollar and seventy-five cents (\$1.75). The underage operative was not asked for identification.

CONCLUSION

Based on the evidence, the Commission finds the licensee violated of 204 CMR 2.05(2), to wit: c.138, §34- Sale or Delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Therefore, the Commission suspends the license for three (3) days of which three (3) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.
