**DECISION**

**SOHAM, INC. D/B/A BEVERLY SHOP 'N GO**  
**199-201 ESSEX STREET**  
**BEVERLY, MA 01915**

Soham, Inc. d/b/a Beverly Shop 'N Go (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, December 20, 2016, regarding an alleged violation of 204 CMR 2.05 (2) – Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, §34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Doyle's Report.

The following documents are in evidence:

1. Investigator Doyle's Compliance Check Field Report dated August 17, 2016; and
2. Licensee's Stipulation of Facts.

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's record.

**FACTS**

1. On Wednesday, August 17, 2016, at approximately 6:41 p.m., Investigators Doyle and Bailey ("Investigators") investigated the business operation of Soham, Inc. d/b/a Beverly Shop 'N Go.
2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a sixteen ounce (16 oz.) can of Budweiser Light beer for one dollar and ninety-nine (\$1.99). The underage operative was not asked for identification.

### CONCLUSION

Based on the evidence the Commission finds the Licensee violated 204 CMR 2.05 (2) - Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, §34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. As the Licensee has been in business for more than 10 years with no prior violations, the Commission issues a **WARNING**.
