NOTICE OF SUSPENSION

June 22, 2016

VIOLATION DATE: From 04/13/1985 to Present

HEARD: 06/21/2016

After a hearing on June 21, 2016, the Commission finds Union Club, Inc. violated:

- 1) M.G.L. c. 138, §1- Failure to file with the Commission annually a list of the names and residences of its officers, together with the amount of salary or compensation received by each employee engaged in the handling or selling of alcoholic beverages;
- 2) M.G.L. c. 138 § 15A- Change of Officers and Directors in the non-profit corporation without authorization.

Therefore, the Commission INDEFINITELY SUSPENDS the license of Union Club, Inc. effective forthwith until further written order of the Commission. The Commission will not issue any further order without a written request from the Licensee showing good cause to reconsider this indefinite suspension and a hearing before the Commission that the Licensee attends.

You are advised that you have the right to appeal this decision under M.G.L. c. 30A to Superior Court within thirty (30) days upon receipt of this notice.

DECISION

UNION CLUB, INC. 141 CABOT STREET BEVERLY, MA 01915 LICENSE#: 010000004

VIOLATION DATE: From 04/13/1985 to Present

HEARD: 06/21/2016

Union Club, Inc. (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, June 21, 2016, regarding alleged violations of:

- 1) M.G.L. c. 138, §1- Failure to file with the Commission annually a list of the names and residences of its officers, together with the amount of salary or compensation received by each employee engaged in the handling or selling of alcoholic beverages;
- 2) M.G.L. c. 138 § 15A- Change of Officers and Directors in the non-profit corporation without authorization.

The above captioned occurred on various dates from 04/13/1985 to the Present, according to Investigator Di Cicco's report.

The following documents are in evidence:

- 2. Licensee's 1985 Corporate Officer List;
- 3. Licensee's 1999 Change of Manager Corporate Vote Listing Officers & Directors;
- 4. Licensee's 2007 Change of Manager Petition;

- 6. Licensee's 2009 Change of Manager Petition;
- 7. Licensee's 2009 Change of Manager Corporate Vote;
- 8. Licensee's 2015 Filing with the Secretary of the Commonwealth for its Officers and
- 9. Licensee's Annual Reports filed with the Secretary of the Commonwealth for 2002 to 2016.

- A. Licensee's Affidavit for Club's Officers and Directors from 1997 to 2016; and
- B. Licensee's Application for Change of Officers and Directors.

There is one (1) audio recording of this hearing.

The Commission took administrative notice of the Licensee's file.

FACTS

1. On April 13, 1985, the Union Club, Inc. filed with the Commission for New Officers/Directors. The filing listed the corporate officers, directors, and managers as:

- 2. After the April 1985 filing, the Licensee did not file with this Commission any documents indicating a change in officers/directors.
- 3. On November 23, 1999, the Union Club voted for Ronald F. Czarnecki to become general manager. This corporate vote indicated officers/directors as:

- 4. On June 27, 2007, Union Club filed a Change of Manager Petition to change the license manager to Peter Gauthier. The Petition and the Corporate Vote were signed by Robert D. Hamilton, who is not an authorized representative of the corporation. The Commission approved the Change of Manager petition on July 25, 2007.
- 5. On April 1, 2009, Union Club filed a Change of Manager Petition to change the license manager to Frederick Spline. The Petition and the Corporate Vote were signed by Matthew A. Kelleher and Tom Smith respectively, both of whom are not authorized representatives of the corporation according to Commission records. The Commission approved the Change of Manager petition on June 23, 2010.
- 6. On March 3, 2015, the Union Club, Inc. filed its Articles of Organization with the Massachusetts Secretary of the Commonwealth indicating the corporate officers, directors, and stockholders as:

7. The Licensee has not annually filed with the Commission a list of the names and residences of its officers, together with the amount of salary or compensation received by each employee engaged in the handling or selling of alcoholic beverages.

DISCUSSION

M.G.L. c. 138, §15A requires that a licensee or applicant for an alcoholic beverages license disclose all individuals who have a direct or indirect beneficial interest in the license. M.G.L. c. 138, §15A. The Appeals Court held in Number Three Lounge, Inc. v. Alcoholic Beverages Control Comm'n, 7 Mass. App. Ct. 301 (1979), the concept of a "direct or indirect beneficial interest" in a license can range from an ownership interest to an absolute proprietary interest to a mere possessory right and includes the right of control. The approved officers and directors of a license corporation are the control group of a corporation. M.C.R.C. Inc. d/b/a Champions (ABCC Decision, June 18, 2014).

The Commission is convinced that the Licensee violated M.G.L. c. 138, §15A (Failure to disclose all individuals who have a direct or indirect beneficial interest in the license). Following the time the Licensee obtained its license 1985, each time the Licensee changed its officers and directors, it should have sought authorization from the Commission.

Likewise, the Licensee should have annually filed with the Commission a list of the names and residences of its officers, together with the amount of salary or compensation received by each employee engaged in the handling or selling of alcoholic beverages. The Licensee's failure to do so is a violation of M.G.L. c. 138, §1.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated:

- 1) M.G.L. c. 138, §1- Failure to file with the Commission annually a list of the names and residences of its officers, together with the amount of salary or compensation received by each employee engaged in the handling or selling of alcoholic beverages;
- 2) M.G.L. c. 138 § 15A- Change of Officers and Directors in the non-profit corporation without authorization.

Therefore, for all of the above violations, the Commission INDEFINITELY SUSPENDS the license of Union Club, Inc. effective forthwith until further written order of the Commission. The Commission will not issue any further order without a written request from the Licensee showing good cause to reconsider this indefinite suspension and a hearing before the Commission that the Licensee attends.
