DECISION

WFM CORP. D/B/A WOODBERRY FOOD MART 157 ESSEX STREET BEVERLY, MA 01915 LICENSE#: 90121-PK-0100

VIOLATION DATE: 4/26/2023

HEARD: 8/01/2023

WFM Corp. d/b/a Woodberry Food Mart ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, August 1, 2023, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Anderson and Bolcome's Minimum Purchase Age Field Report.

The following documents are in evidence:

- 1. Investigators Anderson and Bolcome's Minimum Purchase Age Compliance Check Field Report, 4/26/2023;
- 2. ABCC Licensing Authority Certification, New License Approved, 10/18/2021;
- 3. Licensee's Stipulation of Facts.

There is one (1) audio recording of this hearing.

FINDINGS OF FACT

- 1. On Wednesday, April 26, 2023, at approximately 6:54 p.m., Investigators Bolcome and Anderson ("Investigators") conducted a compliance check at WFM Corp. d/b/a Woodberry Food Mart.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 6-pack of Bud Light beer, for eight dollars and twenty-nine cents (\$8.29). The underage operative was not asked for identification.
- 3. Mr. Amit Patel, Licensee, appeared at the Commission hearing and testified he provides extensive training to employee, and his point-of-sale system displays the date by which a patron must be born to legally purchase alcoholic beverages. Since this incident, Mr. Patel has retrained all employees and plans to have them TIPS certified.

4. The Licensee has held a license under M.G.L. c. 138, § 15 since 2021.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Therefore, the Commission issues a **WARNING.**
