The Chairman called the meeting to order at 1:00 pm and asked the members of the Board and staff to introduce themselves for the record.

### Advertised Regulatory Public Hearing held in accordance with M.G.L. C.30A

The Chairman opened the M.G.L. c. 30A regulatory public hearing at 1:00 p.m. and read the regulatory notice for the public hearing relative to the two proposed amendments to the Massachusetts Electrical Code (527 CMR 12.00). The 1st amendment, s. 445.20, filed on an emergency basis, extends the time (to 1-1-15) within which to comply with a GFCI (ground fault circuit interrupter) requirement for

certain emergency generators. The 2nd amendment, s. 690.12(5), extends the eff. date to 1-1-17 of a current code requirement relating to a listed and identified rapid shutdown system for photovoltaic systems.

The Chairman asked if staff received any written public comments regarding the proposed amendment as invited by the notice.

Mr. Fredette informed the Board that he received one comment of support this morning from Jack Hickman, SMA America on 690.12(5). Copies of the comment from Jack Hickman, SMA America have been distributed to the Board.

The Chairman stated that anyone in the audience who seeks to present comments to the Board on the proposed amendments should complete the public testimony sign in sheet in addition to the regular sign in sheet.

The Chairman asked if there were any public comments relative to the proposed amendments for 527 CMR 12. Hearing none, the Chairman asked the Board for a motion to close the hearing on 527 CMR 12. A motion was made by Dr. Scheiner, seconded by Chief Madison, and unanimously voted by the Board to close the public hearing.

Upon a motion made by Mr. Jeff Cox and seconded by Mr. Fisher, the Board unanimously voted to approve for final promulgation the proposed regulation s. 445.20, filed on an emergency basis, which extends the time (to 1-1-15) within which to comply with a GFCI (ground fault circuit interrupter) requirement for certain emergency generators.

A motion was made by Mr. Jeff Cox and seconded by Mr. Fisher and the Board unanimously voted to approve for final promulgation the proposed regulation s. 690.12(5), which extends the eff. date to 1-1-17 of a current code requirement relating to a listed and identified rapid shutdown system for photovoltaic systems.
