Paul Vigneau discussed the code committee progress on the 2021 version of NFPA 1 with MA amendments. He indicated that there are 75 Chapters; 22 are deleted or reserved, 25 are complete and 4 are substantially complete. That leaves 13 chapters to review mainly from Administration and Correlation, and Hazardous Materials committees.
