Monthly Board Meeting

Monthly meeting called to order at 1:05 p.m.

1. *Minutes from October 20, 2025, meeting of BFPR submitted for approval.*

Motion to approve the October 2, 2025, meeting minutes made by Paul Scheiner, seconded by Paul Kennedy. All in favor. Motion Carries.

New Business

1. *DOL/BBS representatives to have open discussion on the upcoming 527 CMR 1.00 amendment package.*

Attorney Rooney stated, in anticipation of the upcoming promulgation vote for the fire code, the Proposed language has been shared with the BBS to obtain any questions, concerns or feedback from BBS.

2. *Update on NEC 70, 2026 review.*

Chairman Fisher mentioned the NEC 70, 2026 review is still ongoing. There are about 27 proposals remaining to be reviewed. Next meeting scheduled for 11/20/25.

3. *Review 527 CMR 1.00 Draft Amendment Package based on NFPA 1, 2024 edition.*
 - a. *Administrative Committee Chapters 1-9 have been submitted for approval.*

Dr. Scheiner mentioned a meeting was scheduled earlier in the week, but quorum was not met. Another meeting is needed to be sure everything is captured. The first three chapters were reviewed; there was not much discussion of changes needed. The current Mass Amendments rarely have an addition note or year code, we are adding the years associated with the Massachusetts amended cited documents. The question on those is are they the most current version to be considered as the cited document or is there something in an earlier version that we want to cite and not the most recent. No formal decisions were made due to not having a quorum.

Chief Arruda mentioned 1.17.16.1 code change proposal was approved by the board, but missing in Dr. Scheiner's document.

4. *Staff/Equipment Committee report on adoption of 855, 2026 edition.*

Mr. Ibarreta mentioned a meeting was held last week where the committee looked at the new version of 855, the main changes and how that would affect Chapter 52. Members agreed to adopt the 2026 edition as to not fall behind. Members voted to change Chapter 52, the old chapter referenced NFPA 855 but didn't adopt it. The new Chapter 52 would indicate that 855 applies. Some of the text will need to be changed and modified as in the new edition. Chris Towski and Jake Nunnemacher are in the process of drafting the changes to Chapter 52. Next meeting scheduled for 11/20/25 to hopefully review and approve the new chapter.
