DECISION

ASHLEY BROOKE FOODS INC. DBA MANGIA MANGIA 430 BOSTON ROAD **BILLERICA, MA 01821** LICENSE#: 010600052 HEARD: 08/28/2012

Ashley Brooke Foods Inc. dba Mangia Mangia (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, August 28, 2012, regarding an alleged violation of 204 CMR 2.05(2), to wit: c.138, §34. Prior to the commencement of the hearing, the licensee stipulated to the violation alleged in Investigator Doyle's Compliance Check Field Report.

The following documents are in evidence:

- 1. Investigator Doyle's Compliance Check Field Report dated May 14, 2012; and
- 2. Licensee's Stipulation of Facts.

There is one (1) audio recording of this hearing.

FACTS

- 1. On Monday, May 14, 2012 at approximately 07:01 p.m., Investigators Bailey and Doyle conducted an investigation of the business operation of Ashley Brooke Foods Inc. dba Mangia Mangia.
- 2. An underage operative working with investigators purchased an alcoholic beverage, a bottle of Budweiser beer for four dollars and twenty-four cents (\$4.24). The underage operative was not asked for identification.

CONCLUSION

Based on the evidence, the Commission finds the licensee violated 204 CMR 2.05 (2), to wit: M.G.L. c. 138, §34. Therefore, the Commission suspends the license for two (2) days of which two (2) days will be held in abeyance for a period of one (1) year provided no further violations of Chapter 138 or Commission Regulations occur.
