DECISION

NILKANTH STORE LLC D/B/A BEER, WINE & MORE 816 BOSTON ROAD BILLERICA, MA 01821 LICENSE#: 0106-00045

VIOLATION DATE: 5/07/2018 HEARING DATE: 6/26/2018

Nilkanth Store LLC d/b/a Beer, Wine & More (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, June 26, 2018, regarding an alleged violation of 204 CMR 2.05 (2) – Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Doyle's Report.

The following documents are in evidence:

- 1. Investigator Doyle's Compliance Check Field Report; and
- 2. Licensee's Stipulation of Facts.

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's record.

FACTS

- 1. On Monday, May 7, 2018, at approximately 6:42 p.m., Investigators Bailey and Doyle ("Investigators") investigated the business of Nilkanth Store LLC d/b/a Beer, Wine & More.
- 2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a 24-ounce can of Twisted Tea malt beverage, for two dollars and seventy-five cents (\$2.75). The underage operative was not asked for identification.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Therefore, the Commission suspends the license for two (2) days which will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.
