


Purpose

- Create a Safe and Attractive Parkway Space
 - Increase Recreational Use
 - Reduce Impervious Area
 - Increase Treatment of Stormwater
 - Decrease Vehicle Speeds
 - Reconstruct Intersections to Provide Safe Crossings

Project Background


- DCR completed a Feasibility Study in 2021





Proposed Design – Typical section




Proposed Design – Birmingham Pkwy at N. Beacon Street
