Blackstone River and Canal Heritage State Park: Key Findings



- Increase the connection between water quality, recreation, and park management.
- Establish formal agreement to allow DCR and public access to the Millville Lock tract.
- Formalize a reciprocal parking agreement with Tri-River Family Health Center.
- Relocate portable recreation infrastructure out of 1.0%-chance flood zones.
- Multiple trail issues (e.g., excessive trail density, inaccurate maps).
- Opportunities to enhance accessibility by implementing recommendations in 2021 accessibility assessment.

Blackstone River and Canal Heritage State Park, Worcester Visitor Center: Key Findings



- Canal prism and associated towpath provide a tangible connection to the Blackstone Canal within the City of Worcester.
- Visitor Center picnic area, adjacent parking, and operations garage within 1.0%-chance flood zone, and visitor center building, parking, and multi-use path within 0.2%chance flood zone.
- Opportunity to use WVC to promote Environmental Justice.
- Other Issues:
 - Scheduling use of Visitor Center; and
 - Homeless encampments; resolved on DCR property via DCR, contractor, and partner(s).

Blackstone River and Canal Heritage State Park: Comments

- Blackstone River water quality
- Stormwater management at parking area
- Addressing unauthorized trails at Goat Hill
- Possibility of single-purpose trails at Goat Hill
- Eroded trails
- Control of invasive species
- Partnering with municipalities to implement RMP
- Riverbank erosion & stabilization
- Dam removal (WVC)
- Opportunities and Threats revised, and one Recommendation revised

Upton State Forest: Key Findings



- Monitor status of state-Endangered animal currently proposed for listing as Endangered under ESA.
- Develop, permit, and Implement Vegetation Management Plan for Southboro Road bogs.
- Including cultural resources, including cultural landscape features, associated with the Southboro Road bogs.
- Finalize draft Long-Range Interpretive Plan.
- Further implement recommendations contained in 2013 Cultural Resources Management Plan.
- Work with Indigenous partners to inventory, document, conserve, and interpret Indigenous peoples' resources and history.
- Pursue formal public access to landlocked portions of Forest.

Upton State Forest: Comments

- Unauthorized trails, trail density, trail closures
- Parking
- Southboro Road bogs
- Land acquisition
- Paving interior park road (Pratt Hill Rd.)
- Interpreting CCC camp centennial celebration activities
- Numerous additional items
- Dashboard revised; two Threats added and two revised; two Opportunities revised; Land Stewardship Zoning map revised; and one Recommendation added.

Sutton State Forest: Key Findings



- Lack of information about Forest.
- Insufficient parking.
- Extensive unauthorized trails network in Forest and on adjacent property.
- License Agreement with Whitinsville Water Company and associated obligations.
- 34-acre Waters Airport opportunity for DCR to enhance conservation and showcase efforts.

Purgatory Chasm State Reservation: Key Findings



- Opportunity to serve as gateway to both the Reservation and Sutton State Forest (VC, trail connections, etc.).
- > Popular chasm rim trail is not sustainable.
- Approximately 1,500-feet of main loop trail (Charley's Loop) is located on private property.
- Wellhead Protection Area Zone Lissues on south side (i.e., chasm side) of Purgatory Road.
- Opportunity to enhance accessibility by further implementing recommendations in 2018 accessibility assessment, and creation of web-based video tour of inside of chasm.

Southern New England Trunkline Trail: Key Findings



- 3 Sections (West, Central, East); each with distinct character (e.g., trail surface, identity, user group).
- Need for common identity and branding along entire length.
- Need to clarify management and public communication of management.
- Historic railroad resources are excellent candidates for preservation and interpretation.
- Improvements to West Section can enhance recreation and stream connectivity.

Southern New England Trunkline Trail: Comments

- Expansion eastward to downtown Franklin
- Connections among sections
- Erosion/drainage along trail & needed repair work
- ATV incursions
- Need for signs and regulations
- Desire for additional amenities (benches, trash barrels, dog waste bags, etc.)
- West Section trail surface
- Revise scope/content of RMP to provide detailed info on maintenance (e.g. vegetation management requirements) and upgrade of SNETT (budgets)
- Eight Opportunities added; four Recommendations added, one revised, and two deleted.

Douglas State Forest: Key Findings



- Excellent opportunity for landscape-scale management of natural and cultural resources (MA and RI).
- Regional hub for long-distance trails (i.e., Air Line State Park Trail, Mid-State Trail, SNETT, North-South Trail).
- Wallum Lake Terrace Beach Association operates private recreation area in Forest without legal agreement or allowing public access.
- Only known Massachusetts population of a State Endangered plant is in Wallum Lake.
- Non-conforming pit privy at backcountry campsite along Mid-State Trail.
- Wellhead Protection Area Zone Lissues at Wallum Lake Day Use Area.

Douglas State Forest: Comments

- Use of CCC cottage at Wallum Lake
- Trail density, unauthorized trails, & trail closures (especially regarding equestrians)
- Expansion of Forest
- Parking (tow-vehicles and trailers)
- Water quality monitoring at Wallum Lake
- One Threat revised, one Opportunity added, one Recommendation added
