2. Statement of Concern:

I want to thank you all for the opportunity to have had such a long and rewarding career as a MA Licensed Optician. My concern is that, despite the dedication and diligent volunteer service provided to the Commonwealth by the members of the BOR for Dispensing Opticians, the current executive order may result in either the diminishing, or even the possible sunsetting of our MA license for Opticians. If this were to take place, it would have a detrimental, perhaps devastating, effect upon the quality of eye care provided to the general public, as well as to the development of our future MA leaders in the optical profession.

Supporting Statements:

Many mass optical retailers have reported that their MA locations are consistently amongst the highest performing locations in the country. It is not unusual for many of the mass retailers to showcase their MA

locations for their great success in both sales, and customer service. Many of the mass retailers have flagship stores located in MA.

High sales matched with high performance in customer service and satisfaction is the direct result of customers receiving quality and advanced technical care.

Basically, since opticianry in MA is a licensed profession, optical stores of any type, employ only those opticians who meet the requirements of licensure and are truly knowledgeable and technically skilled.

From a leadership perspective, I have had the great opportunity to be mentored by some of the finest opticians in MA. Early ion my career I was fortunate to work along side with Kenneth Collinson. It was his court victory in the 1970's that defined contact lenses as a "medical Device or apparatus" and allowing the fitting and contact lenses to be a part of the opticians license.
