The Blandford Country Store Inc. d/b/a The Blandford Country Store (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, February 25, 2020, regarding an alleged violation of 204 CMR 2.05 (2)- Permitting an illegality on the licensed premises, to wit: M.G.L. Ch.138 § 34- Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigator Gould's Report.

- 1. Investigator Gould's Compliance Check Field Report;
- 2. Licensee Stipulation of Fact;
- 3. Copy of License Transfer Application Summary Review Approval, 4/27/2018.

FACTS

- 1. On Wednesday, September 4, 2019, at approximately 5:08 p.m., Investigators Kujawski and Gould ("Investigators") conducted an investigation of the business operation of The Blandford Country Store Inc. d/b/a The Blandford Country Store.
- 2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a 12-ounce container of Bud Light beer, for two dollars and four cents (\$2.04). The underage operative was not asked for identification.
- 3. Jennifer Girard, the Licensee and manager of record, appeared at the Commission hearing and testified that employees are trained to request identification prior to making a sale.

- 4. Ms. Girard informed the Commission that there is a calendar at the register indicating the date by which a person must have been born in order to be 21 years of age, and allowed to purchase alcohol.
- 5. The Licensee has held a license under M.G.L. c. 138, § 15 since 2018 with no prior violations.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2)- Permitting an illegality on the licensed premises, to wit: M.G.L. Ch.138 § 34- Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. The Commission issues a **WARNING**.
