Dr. Storozuk informed the Board that Governor Baker is slated to sign a proclamation celebrating Chiropractic's 50 years of licensure in Massachusetts on June 28 at the State House. More details to come.

MEETING MINUTES

Motion was made by Dr. Reida to approve the March 3, 2016 Public Minutes. Seconded by Dr. Dodes. Motion passed unanimously.

Update on Investigative Matters from the Unit Chief and Deputy Chief

Chris Carroll, Chief of the Investigative Unit, reported to the Board that 223 inspections were performed in 2014 and 393 in 2015. The number of complaints from Insurance companies is down, as are the number of complaints at the consumer level. He credits this to a proactive Board and the Office of Investigations' efforts.

Dr. Reida made a motion, seconded by Dr. Dodes and **VOTED** unanimously to accept Dr. Marshall as ChoR for BCC.

LEGAL REPORT

Sheila York Esq. gave the Board an update regarding the **E.O. 562 regulation review project**. She reports that the Office of Consumer Affairs and the Secretariat of Housing and Economic Development had some questions regarding the primary care provider language that the Board was proposing to add to Section 4.00. They were concerned that the term "primary care provider" has a particular meaning in the insurance industry and adding it to the Board's regulations at this time could cause confusion for patients and interested parties. The Secretariat suggested that the Board take the primary care provider language out and proceed with the other proposed changes, including the Peer Review regulations. The document will go back to the Secretariat with the changes. Administration and Finance is the next step.

Reinstatement [JG]

Dr. Dodes recused himself. The Board considered the re-instatement petition of Joseph Giampa. Board Counsel discussed Mr. Giampa's disciplinary history, statements made in support of his request for reinstatement, and the Board's responsibility to act in the best interest of the public health, safety and welfare. Board Members discussed the scope of the misconduct that resulted in the petitioner's loss of licensure, and their significant concerns regarding the petitioner's current ability and willingness to comply with the laws and regulations governing chiropractic.

Dr. Imonti made a motion, seconded by Dr. Reida and it was **VOTED** unanimously to deny Mr. Giampa's request for reinstatement at this time.

Dr. Dodes returned to room.

CE Applications

Dr. Reida presented his recommendations regarding the current CE applications. A motion was made by Dr. DeVeuve, seconded by Dr. Imonti and it was voted unanimously to approve application # 4531 15-387 – 4552 15-408 as presented.

Roll call vote. Dr. Storozuk, Dr. DeVeuve, Dr. Reida, Dr. Imonti and Dr. Dodes all in favor. None opposed. The Chair announced that he estimated that public session would resume in five minutes.

Public session resumed at 2:27 p.m.

Dr. Storozuk noted there were no more agenda items. Therefore a motion was made by Dr. Reida, seconded by Dr. Dodes, and was voted unanimously at 2:28 p.m. to adjourn the April 7, 2016 public meeting of the Board of Registration of Chiropractors.
