CALL TO ORDER: The meeting was called to order by Mr. Favorito at 1:30 p.m.

Item #1 **MOTION- VOTE**

Acceptance and Approval of October 2, 2019 Minutes

The motion was made by Ms. Pinaud and seconded by Mr. Favorito and voted unanimously in favor of tabling.

Item #2 **REPORT OF THE EXECUTIVE COMMITTEE**

Ms. Perez reported that the Governor's Fiscal Year 2019 Supplemental Budget has not been passed by the Legislature. Due to the delay, the Executive Committee is waiting to finalize the school drinking water bottle filling station program, since renamed School Water Improvement Grants (SWIG), and the Polyfluoroalkyl Substances (PFAS) financing program. There are sufficient funds for the SWIG program to proceed without the Supplemental Budget being passed but the Commissioner of MassDEP had previously wanted to get legislative approval before moving forward.

Ms. Pinaud said that it is best to coordinate the roll out of the SWIG program and the Water Infrastructure Improvements for the Nation Act (WIIN) grant program since both involve addressing lead in drinking water in schools and should be announced at the same time to incentivize participation.

Ms. Kowtoniuk said that an announcement on the final Supplemental Budget is expected to be made the week of November 10th.

The Trust will continue to monitor the legislation and will report to Board if anything changes.

Ms. Perez said that the Trust's Series 22 bond deal closed on October 24th and the final par amount was \$192 million. The sale had strong retail participation from inside and outside the state, with 148 individual retail orders being placed. The interest rate for this deal was approximately 100 basis points lower than the Series 21 bond deal that closed in 2018.

Ms. Pinaud said that 2020 Intended Use Plan (IUP) projects have been ranked. There was a large number of proposals submitted during the solicitation period for Drinking Water and Clean Water projects, and for the second round of the Asset Management Planning grants. The next step is for MassDEP and the Trust to review program capacity to decide how many projects can be offered financing on the 2020 list.

Item #3 **MOTION – VOTE REQUESTED**

The motion was made by Mr. Favorito and seconded by Ms. Pinaud.

Ms. Perez explained how the Trust is allowed to transfer up to 33.3% of that year's Clean Water federal grant to the Drinking Water Program each year. The transfer has been done for the past five years.

The motion was voted unanimously in favor of acceptance and approval of the following:

Authorization of a Permanent Funds Transfer from Clean Water to Drinking Water Equity in the amount of \$8,425,890

- 1. That, pursuant to and as further implementation of the Funds Transfer Program approved by the Board on January 8, 2014, the Board hereby re-affirms and approves the Executive Director's authority to make such transfers between the Clean Water SRF and the Drinking Water SRF as she determines to be necessary, including a permanent transfer of \$8,425,890 from the Clean Water SRF to the Drinking Water SRF.
- 2. That the Executive Director is further authorized to take all necessary steps to effectuate such transfer, including executing and delivering all letters, certificates, and other instruments and documents necessary or desirable in connection therewith and obtaining any necessary opinions of counsel.
