Item #2 **REPORT OF THE EXECUTIVE COMMITTEE**

EPA Grants

Ms. Perez said that the Trust's applications for the EPA capitalization and supplemental Clean Water grants have been accepted.

The Trust has applied for \$5.8 million of the \$13 million available for the Supplemental Drinking Water grant set-asides, the remainder will be used for drinking water projects. We also applied for \$17.1 million of the \$20.4 million available for the new Lead Service Line (LSL) grant set-asides. The remainder will be used for lead service line projects. A majority of the LSL set-asides will be used to fund the LSL Planning Program. The first of these project loans is up for vote today.

2021 Intended Use Plans

Ms. Perez stated that the Trust is reviewing the 2021 projects that are proceeding. Some borrowers have had bid results higher than expected which has led to them being granted extensions to the June 30th loan forgiveness deadline. This will delay when loan forgiveness amounts for all eligible 2021 projects will be up for Board approval.

New Technical Assistance Program

Ms. Perez said the Trust will be applying for the new 2% Technical Assistance Set-Aside grant which will allow us to start a new program for small, rural, and tribal publicly owned treatment works using the Clean Water State Revolving Fund.

2023 Intended Use Plan (IUP) Solicitation

Ms. Pinaud said that the solicitation for 2023 IUP is currently open and closes on August 12th. MassDEP has already received several applications, and most applications are expected to be submitted in the final week of the application window.
