2. 24 Yawkey Way – Boston, MA

**GEDA Lift System** 

Owner: Boston Red Sox Petitioner: John Ryan

The petitioners reappeared before the Board requesting a variance to allow the installation of a GEDA Transport Platform for the 'Big Air Fenway' event to be held on February 11, 2016 & February 12, 2016. The petitioners were placed on hold at the January 26, 2016 Board Meeting. The petitioner returned with a representative from Kone Elevator Company to discuss this lift in more detail. The Board agreed that this unit does not meet the full requirements of a passenger elevator. The Board was primarily concerned with the safety features on this unit. The proposed transport platform will reach a height of 125-feet and withstand a 3300 load capacity. The unit has two gates that will only be open when it reaches the landing. The unit has emergency lowering. The Board asked the petitioners to generate a list of code sections where this unit is in need of a variance. A motion was put forth by Tom Riley to place this variance on hold until

the petitioners can provide more information on the unit. The motion was seconded by Dave Gaudet. John O'Donoghue and Mike Nicoloro excused themselves from the meeting.

### 3. 5 Peatfield Street – Ipswich, MA

524 CMR 34.09

Owner: EBSCO Publishing Petitioner: Jay Lawrence

The petitioners came before the Board seeking a variance to allow security swipe pads on their wheelchair lift located at 5 Peatfield Road in Ipswich. The petitioners want to install this security feature to prevent local youth from damaging or getting injured by the lift. The Board referred the petitioners to speak with Tom Hopkins, who is the Architectural Access Board Director. A motion was put forth by David Gaudet to deny the variance. The motion was seconded by Tom Riley.

#### 4. 415 Summer Street – Boston, MA

524 CMR 35.00 § 3.26.4.2(f)

**Owner: Massachusetts Convention Center Authority** 

**Petitioner: Robert Chiampi** 

The petitioner came before the Board seeking a variance under 524 CMR 35.00 § 3.26.4.2(f) – "in-car stop switch, where required by 2.26.2.21". The hydraulic elevators in this building were installed in 2001 and were not designed with the anti-creep feature. The stop switch is keyed and behind a locked panel. The only people with access to this key are Group 1 Security personnel. A motion was put forth by Cheri Davis to grant the variance for units 1-P-11344, 1-P-11345, 1-P-11346, 1-P-11343, 1-P-11332, & 1-P-11334 under 524 CMR 35.00 § 3.26.4.2(f) with the understanding that the stop key is only handled by Group 1 Security personnel. Also, this variance is only valid until the unit's controller is changed. The motion was seconded by Tom Riley.

#### 5. 399 Boylston Street – Boston, MA

ASME A17.1-1996 2000.7a Owner: Equity Office Petitioner: Wayne Talbot

The petitioners came before the Board requesting a variance to exceed the vertical travel height on a wheelchair lift. The petitioner stated that this is an enclosed lift with two stops and the unit doesn't penetrate a floor. The petitioner is requesting to extend the vertical travel distance of the lift to 13'-2''. The Board reviewed the architectural drawings. A motion was put forth by Tom Riley to grant the variance from 524 CMR 35.00 Part XX 2000.7a to allow 13-ft 2-inches of vertical travel. The motion was seconded by Harry McGonagle.
