- 15. Reinstatement request for Dr. Ikeda. On a motion by Dr. Jones, and seconded by Dr. Glover, the board voted to reinstate the license and subsequently open a complaint against the applicant for unlicensed practice. All were in favor.
- 16. On a motion by Dr. Scherer, seconded by Dr. Glover, the board meeting minutes were unanimously approved from the July meeting.
