Thereafter, Dr. Shilts was ELECTED (unanimous);  
**to the position of Board Secretary for the 2019/20 term.**

#### **CHIROPRACTOR OF RECORD (CHoR) WAIVER APPLICATION**

The Board interviewed Dr. Junji Zang for the position of CHoR for licensed Chiropractic Facility (CF) “Prime Care Chiropractic” in Malden.

Thereafter, a motion was made by Dr. Martone, seconded by Dr. Shilts and VOTED (unanimous);  
**to grant a CHoR waiver to Dr. Junji Zang relative to CF #483 .**

Thereafter, a motion was made by Dr. Martone, seconded by Dr. Maddalo and VOTED (unanimous);


