### **Board Business:**

1. At 9:12 a.m., the meeting was called to order by Dr. Carey.
2. Dr. Carey reviewed evacuation instructions.
3. On a motion by Dr. Jones, seconded by Dr. Marshall, the board meeting minutes of the public meeting on February 8, 2019 were approved. All were in favor.
4. Reviewed Dr. DePaul report and request to terminate probation. On a motion by Dr. Jones, seconded by Dr. Anderson, the board agreed to accept the report as written and to terminate Dr. DePaul's probation. All were in favor.
5. Reviewed Dr. Gentile report. On a motion by Dr. Anderson, seconded by Dr. Hudgins, the board agreed to accept the report as written. All were in favor.
6. Reviewed proposed consulting psychologist for Dr. Marans. The board directed staff to notify Dr. Marans that Dr. Raab is not approved to be her consulting psychologist at this point because the board is not convinced that she fits the requirements of the consent agreement. Dr. Marans can either come in with Dr. Raab for an interview with the board or submit one or more new candidates.
7. At 9:37 a.m., on a motion by Dr. Jones, and seconded by Dr. Marshall, the board voted to move into closed session to conduct an investigative conference pursuant to M. G. L. c. 112, § 65C; c. 30A, § 18, ¶ 5(d). All were in favor.

  - 2018-001309-IT-ENF (HC): On a motion by Dr. Marshall, seconded by Dr. Anderson, the board voted to dismiss the complaint. All were in favor.
10. At 10:27 a.m., on a motion by Dr. Marshall, seconded by Dr. Hudgins, the board voted to adjourn the meeting. All were in favor.
