- **Public Meeting Minutes of September 12, 2025:** After a brief discussion, a motion was made by Dr. Anderson, seconded by Dr. Brown, to approve the Public Meeting Minutes of September 12, 2025. The motion passed unanimously by a roll call vote.

- **Executive Session Minutes of September 12, 2025:** After a brief discussion, a motion was made by Dr. Seligowski, seconded by Dr. Edwards George, to approve the Executive Session Minutes of September 12, 2025. The motion passed unanimously by a roll call vote.
