- **Public Meeting Minutes of November 14, 2025:** After a brief discussion, a motion was made by Dr. Anderson, seconded by Dr. Seligowski, to approve the Public Meeting Minutes of November 14, 2025. The motion passed unanimously by a roll call vote.
- **Executive Session Minutes of November 14, 2025:** After a brief discussion, a motion was made by Dr. Anderson, seconded by Dr. Brown, to approve the Executive Session Minutes of November 14, 2025. The motion passed unanimously by a roll call vote.

Discussion

- **Legislative Update:** Jonathan Dillon, Bureau of Health Professions Licensure (BHPL) Director of Policy and Lauren Nelson, BHPL Deputy Director appeared to discuss important pending legislation that may impact the Board. Specifically, Mr. Dillon discussed *An Act Establishing the Psychology Interjurisdictional Compact* (S. 1487/H. 2528) and *An Act Establishing Senior Psychologist Licensure* (H. 462). He explained what the bills would do and the impact of both bills on the Board and its licensees if they become law.

Monitoring

- **Elizabeth Nasser, 2022-000696-IT-ENF and 2022-001023-IT-ENF, Approval of Proposed Supervisor and 1st Quarterly Monitoring Report:** The Board reviewed the report and Dr. Nasser's request that the Board approve William Stone as her supervisor retroactively. After a brief discussion, the Board directed Mr. Bialas to invite Dr. Nasser and Dr. Stone to a meeting for an interview.

Executive Session (closed under G.L. c. 30A, § 21(a)(7) to comply with G.L. c. 4, § 7, ¶ 26(c) and G.L. c. 214, § 1B – adhering to the public records law and to preserve the confidentiality of medical record information)

At 9:54 a.m., a motion was made by Dr. Brown, seconded by Dr. Anderson, to (1) exit the public meeting; (2) enter into executive session under G.L. c. 30A, § 21(a)(7) to comply with G.L. c. 4, § 7, ¶ 26(c) and G.L. c. 214, § 1B – adhering to the public records law and to preserve the confidentiality of medical record information, to discuss and evaluate a request for an extension to complete application experience not within 60 months and examination accommodation requests that involve the review of medical records and information of patients; then (3) enter into investigative conference under G.L. c. 112, § 65C to review settlement offers and new cases; and (4) at the conclusion of the investigative conference, not return to the public meeting and adjourn. The motion passed unanimously by a roll call vote.
