The meeting was called to order at 9:37 a.m.

Board Business

- **Public Meeting Minutes of March 22, 2022:** After a brief discussion, a motion was made by Mr. Powers, seconded by Ms. Pierre-Victor, to approve the Public Meeting Minutes of March 22, 2022. The motion passed unanimously.
- **Executive Session Minutes of March 22, 2022:** After a brief discussion, a motion was made by Ms. Fuller, seconded by Mr. Powers, to approve the Executive Session Minutes of March 22, 2022. The motion passed unanimously.
- Adjudicatory Hearing Scheduled in 2020-001094-IT-ENF (VS) for 10 a.m. on August 24 and 25, 2022: Mr. Bialas reported that an adjudicatory hearing has been scheduled, and board members wishing to attend may contact Mr. Bialas.
- **DOL Enforcement Process:** Mr. Henderson and Ms. Alleyne provided an overview of the complaint enforcement process at DOL.

Application Review Interview – Prior Discipline

• Kerry Higgins, Applicant for LSWA: Ms. Higgins appeared to discuss her application for LSWA and prior discipline on her former LICSW license for marrying a former client. Her LICSW license was suspended in 2010, and, after her term of suspension, she had to complete probation with specific conditions to reinstate her LICSW license. She successfully completed the disciplinary terms on her license in 2013 and let her LICSW license expire in 2018.

Ms. Higgins explained that she is interested in a position at UMass doing disability, case management work that she can perform while living in Washington State, but the position requires a Massachusetts license. The position only involves case management services and no therapy. She is applying for the LSWA license because she does not think she could pass the LICSW examination right now.

The Board expressed concerns that a former LICSW like Ms. Higgins would be tempted to perform clinical work as an LSWA and requested that Ms. Higgins apply for the LCSW license so she would be supervised on a track to get her LICSW license again.

Ms. Higgins agreed to withdraw her LSWA application and apply for the LCSW license.

Application Review – Negative Reference

• Jill Demeny, Applicant for LCSW: The Board reviewed Ms. Demeny's request that the Board reconsider its decision to require Ms. Demeny to agree to a conditional licensure agreement to sit for the LCSW examination. After a brief discussion, the Board decided to interview Ms. Demeny at a future meeting.

Ms. Ruiz was recused from the matter and took no part in the discussion of it.

Application Review – Prior Discipline

• Helen Loewenthal, Applicant for LICSW Renewal: The Board reviewed Ms. Loewenthal's disclosure of past discipline in Rhode Island on her renewal application. After a brief discussion, the Board decided to interview Ms. Loewenthal at a future meeting.

• Sandra Garcon, 2019-000571-IT-ENF, Petition to Terminate Suspension: The Board reviewed Ms. Garcon's petition to terminate suspension. After a brief discussion, the Board decided to interview Ms. Garcon at a future meeting.

At 10:51 a.m., a motion was made by Ms. Carrington, seconded by Ms. Pierre-Victor, to exit the public meeting and enter into a closed executive session under G.L. c. 30A, § 21(a)(1), individual character rather than competence, to interview an applicant regarding her good moral character, and under G.L. c. 30A, s. 21(a)(7) to comply with G.L. c. 4, s. 7, para. 26(c) and G.L. c. 214, s. 1B, to review sensitive personal and medical information in an interview regarding a petition to terminate a conditional licensure agreement and a petition to approve a fitness to practice evaluator. The motion passed unanimously by a roll call vote.
