Post-suspension petition for license reinstatement

The Board reviewed the packet of materials that the licensee compiled for review by the Board, in accordance with the Board's Policy governing license reinstatement following license suspension, and found it complete. Curtis Jackson, MPRS Coordinator, provided an update to the Board.

Mr. Burns made a motion to terminate license suspension; Mr. Riendeau seconded the motion. The motion passed unanimously.

Motion by Mr. Riendeau to reinstate license pending the licensee's signing a postsuspension consent agreement for probation for a period of not less than three (3) years and with terms to include his continued participation in, and compliance with, the terms of his contract with MPRS, no criminal activity, verification of current NBRC certification, and contingent license surrender for failure to comply with all

agreement terms. Mr. Riendeau seconded the motion. The motion passed unanimously.

The Board reviewed the materials submitted by the licensee involving a criminal case in Connecticut from 2004; a current Massachusetts CORI report is negative.

Mr. Riendeau made a motion to approve the reactivation application and to notify the licensee that .3 CEUs submitted for the 2012-2014 license reactivation period will be counted towards the 2010-2012 license reactivation period. Mr. Burns seconded the motion. The motion passed unanimously.

The Board reviewed the documents obtained by Karen Fishman, Probation Monitor, from the criminal court reflecting that the licensee has pending criminal charges. The licensee was terminated from employment as an RT on January 11, 2013.

Ms. Stein informed that Board of her conversation with Paul Starr, Esq., who contacted her with regard to the letter sent the licensee on February 7, 2013, advising him of the Board's anticipated action and offering an opportunity respond to the new complaint at the Board's February 13th Meeting. The licensee did not attend Board Meeting or provide a response. Attorney Starr submitted a letter requesting that the licensee have an opportunity to provide further information relative to the pending criminal charges and to present same at the next monthly meeting.

Mr. Burns made a motion to immediately suspend License No. 9856 in accordance with the terms of his Probation Agreement for violation of its terms, to wit, engaging in conduct that resulted in his arrest for violation of criminal law, and to inform the licensee of the suspension and of the opportunity to appear at the March 2013 Board Meeting provided he confirms his attendance by February 11, 2013. Mr. Riendeau seconded the motion. The motion passed unanimously.

Ms. Stein summarized the information relative to the licensee's surrender of his RCP license under a Consent Agreement with the Maine Board of Respiratory Care Practitioners in December 2011 for failing to disclose criminal convictions on his application for RCP licensure and his conviction in U.S. District Court in April 2012 for health care fraud and knowingly making a false statement on a loan application submitted to the Small Business Administration on behalf of three (3) medical supply companies. The licensee is currently incarcerated at a federal prison in Pennsylvania.

Mr. Burns made a motion to offer the licensee a consent agreement for the voluntary surrender of his right to renew his license based on the surrender of his ME RCP license and his convictions in federal court; Mr. Riendeau seconded the motion. The motion passed unanimously.

Allegation: Inadequate or fraudulent documentation

Ms. Graham informed the Board that she had just opened a complaint against the licensee's RT license alleging that the licensee had been terminated from employment for improprieties relative to the licensee's documentation of the periodic maintenance of facility medical equipment.

Mr. Riendeau disclosed that as a RT he had worked with the licensee in 1974.

The Board agreed to defer action until the investigation is complete.

Ms. Graham informed the Board that Ms. Mack resigned her position on the Board effective December 31, 2012. Ms. Mack's noted in her resignation letter that, based on anecdotal information, she has concerns about unlicensed practice of respiratory care in the homecare field.

Board members requested that additional resources be made available to the Board to inform homecare companies about Board statutory and regulatory requirements. Mr. Kanter agreed to assist the Board in pursuing its concerns.

Mr. Riendeau made a motion to nominate and elect Mr. Burns as Board Chair with the agreement that another election would be held in July 2013, when Ms. Mack's term as Chair would have ended; Mr. Burns seconded the motion. The motion passed

unanimously.
