Introduction and Procedural History of this Appeal

The claimant appeals a decision by a review examiner of the Department of Unemployment Assistance (DUA) to deny Pandemic Unemployment Assistance (PUA benefits). We review, pursuant to our authority under G.L. c. 151A, § 41, and affirm.

The claimant filed a claim for PUA benefits with the DUA, effective March 15, 2020, which was denied in a determination issued on January 6, 2021. The claimant appealed the determination to the DUA hearings department. Following a hearing on the merits, the review examiner affirmed the agency's initial determination in a decision rendered on May 18, 2021, concluding that the claimant had failed to establish that she was working in Massachusetts when she became unemployed for a COVID-19 listed reason under the Coronavirus Aid, Relief, and Economic Security (CARES) Act of 2020, and, thus, the claimant was not eligible for PUA benefits. We accepted the claimant's application for review.

Ruling of the Board

After considering the recorded testimony and evidence from the hearing, the review examiner's decision, and the claimant's appeal, we conclude that the review examiner's decision is based on substantial evidence and is free from any error of law affecting substantive rights.

The record shows that the claimant had been working in a nail salon in Wisconsin when the salon had to shut down due to COVID-19 mandated closure of all non-essential businesses. This business shut down is a COVID-19 listed reason for PUA eligibility under the CARES Act 2102(a)(3)(A)(ii)(I)(jj). However, the U.S. Department of Labor has directed that a claimant must file for PUA benefits in the state where she was working at the time she became unemployed due to the COVID-19 public health emergency.¹ Since the claimant was not working in Massachusetts, she is not eligible to file a PUA claim in Massachusetts. The claimant may be eligible to file a PUA claim in Wisconsin.

The review examiner's decision is affirmed. The claimant is not entitled to receive PUA benefits in Massachusetts as of the week beginning March 15, 2020.
