Presentation by Robert Notch, Chairman of the NASDVA Boston 2018 Conference Board

Robert Notch discussed the NASDVA Conference that will be held from August 12-15, 2018, in Boston MA. He mentioned that the Trustees may participate as a vendor or sponsor. Each Trustee received copies of the sponsorship letter and talking points. Robert also briefed the Chelsea Soldiers' Home (CSH) Trustees during their February 2018 Board Meeting. After the presentation concluded, Bennett W. Walsh mentioned that the CSH took the proposal under advisement. Benjamin H. Cluff asked that this topic be placed on the May agenda.

• New Business

Benjamin entertained a motion to replicate last year's dollar amount (\$5,000.00) for the son, daughter or ward of a Soldiers' Home employee. Upon motion by Cindy T. Lacoste and seconded by Cesar A. Lopez, it was unanimously VOTED to approve \$5,000.00 for the Board of Trustees' Scholarships.
- O John K. Crotty presented and explained the following management plans for approval by the Trustees, which are reviewed annually: Emergency Operations; Life Safety; Safety & Security; Medical Equipment; Fire Prevention & Preparedness; Utility; and Hazardous Materials & Waste (with one (1) change only: Material Safety Data Sheets are now referred to as Safety Data Sheets). Upon motion by Cesar A. Lopez and seconded by Brian Q. Corridan, it was unanimously VOTED to approve all the aforementioned management plans.
- Under the Superintendent's Report, Bennett W. Walsh mentioned about meeting with the Northampton State Police Commander, on Wednesday, regarding a security assessment. Brian Q. Corridan requested that whoever conducts the security analysis, present themselves to the Trustees during a meeting and to give us an idea of what it will entail. Upon completion of the analysis, he also requested a summary to the Trustees. Bennett will discuss this with the Commander.
