## **Meeting Called to Order**

9:34 a.m.: Dr. Kube, Chair, opened the meeting.

## **Board Business**

- **Public Meeting Minutes of June 13, 2019:** The Board reviewed the public meeting minutes of June 13, 2019. Dr. Diamond made a motion to approve the public meeting minutes, seconded by Dr. Patti. The motion passed unanimously.
- **Executive Session Meeting Minutes June 13, 2019:** The Board reviewed the executive session meeting minutes of June 13, 2019. Dr. Diamond made a motion to approve the executive session meeting minutes, seconded by Dr. Kube. The motion passed unanimously.

## **Executive Director Report**

• **2019 AAVSB Annual Meeting & Conference:** The board members regretfully are unavailable to attend to the conference.



#### Discussion

Proposed Joint Policy Statement on Pet Shops, Animal Shelters and Rescues from
Division of Animal Health: Lisa Kaufman raised concerns with language in regards to
animals who are ready for adoption who would be required to stay in shelter environment
if on medication. Susan Curtis of the MVMA also raised concerns to the policy defining
standard of care not specified by licensing authority ultimately becoming problematic for
veterinarians. Cynthia Cox (MSPCA) reiterated both points and also added that over
regulating within the policy can ultimately be more harmful to the animals leading to
more unnecessary cases of euthanasia. Dr. Diamond suggested removing, "Veterinarians
caring for animals in a pet shop, animal shelter or rescue shall not declare an animal fit
for sale/adoption while it is receiving a prescribed course of medication."
The Board members as well as Susan Curtis and Cynthia Cox have offered to review and
edit the policy, before any further discussion on approval.

## **Application Review**

• Joseph Marchell Reference form: A motion was made by Dr. Diamond to accept the reference form from the applicant's mother as she is a licensed veterinarian. The motion was seconded by Dr. Kube. The motion passed unanimously.

- Stephen Caldwell, 2016-000078-IT-ENF and 2017-000533-IT-ENF, Review of 1<sup>st</sup> Quarterly Report dated 6/19/19: After discussion, the board would like to see the report resubmitted based on the approved Instructions for Monitoring from the June 13, 2019 board meeting.
- James Lear, 2018-000813-IT-ENF, Review of Required CE's for Consent Agreement: Dr. Patti motioned to approve the Brachycephalic Airway CE and not accept the Update on Analgesia/Anesthesia CE for surgical and post-surgical complications course content. The motion was seconded by Lisa Kaufman and passed unanimously with the exception of Dr. Diamond who recused himself from the discussion.
