- After a lengthy discussion on a MOTION by John Naff and seconded by Robert Speroni it was
  unanimously voted all certification requirements, besides continuing education, are frozen from
  March 10, 2020 until the State of Emergency has been rescinded. Individuals will be responsible to
  review their timeframe and file for Extension of Time or Application for Certification
  appropriately once the State of Emergency has been lifted. Building inspectors are able to continue
  to file applications for certification and extension of time to be certified for review during
  Certification Committee's scheduled meetings.

The current training cycle will end December 31, 2020, to accumulate at least 45 credit hours, or the appropriate number of credit hours if pro-rated, is still required. Individuals unable to satisfy this requirement will be reviewed on a case-by-case situation.
