Meeting called to order by the Chairman at 9:37 a.m. followed by roll call:

2. Members present reviewed minutes from the BOCC meeting on March 1, 2022: MOTION to was made by Dave Fuller and seconded by John Naff. Vote was unanimous.

3. Application for Certification Packets

- a. On a MOTION by Michael Giampietro and seconded Michael Clancy it was unanimously VOTED to approve the application of **Christopher Broderick** (City of Boston) for certification in the capacity **Inspector of Buildings / Building Commissioner** having met the minimum qualifications for said position defined by MGL c 143 § 3. (BO-2024).
- b. On a MOTION by Michael Giampietro and seconded Andy Bobola it was unanimously VOTED to approve the application of **John DeVito** (City of Everett) for certification in the capacity **Local Inspector** having met the minimum qualifications for said position defined by MGL c 143 § 3. (BO-2260).
- c. On a MOTION by John Naff and seconded Dave Fuller it was unanimously VOTED to approve the application of **Richard R. Forand** (No Affiliation) for certification in the capacity **Local Inspector** having met the minimum qualifications for said position defined by MGL c 143 § 3. (BO-2301).

- d. On a MOTION by Michael Giampietro and seconded Michael Clancy it was unanimously VOTED to approve the application of **Michael Halley** (Town of Braintree) for certification in the capacity **Inspector of Building Commissioner** having met the minimum qualifications for said position defined by MGL c 143 § 3. (BO-1974).
- e. On a MOTION by Michael Giampietro and seconded Dave Fuller it was unanimously VOTED to approve the application of **Daniel LaFlamme** (City of Springfield) for certification in the capacity **Local Inspector** having met the minimum qualifications for said position defined by MGL c 143 § 3. (BO-2282).
- f. On a MOTION by Michael Giampietro and seconded Henry Fontaine it was unanimously VOTED to approve the application of **David Palumbo** (City of Lawrence) for certification in the capacity **Massachusetts Building Commissioner** having met the minimum qualifications for said position defined by MGL c 143 § 3. (BO-2008).
- g. On a MOTION by Michael Giampietro and seconded John Naff it was unanimously VOTED to approve the application of **Anthony Whitman** (No Affiliation) for certification in the capacity **Local Inspector** having met the minimum qualifications for said position defined by MGL c 143 § 3. (BO-2302).

4. Examination Approval Packets

- a. On a MOTION by John Naff and seconded by Michael Clancy it was unanimously VOTED to DENY the request of **William Burruss** (No Affiliation) for approval to take the required exams to become certified as a building code enforcement official. The Committee was unable to find sufficient supervisory experience in building construction or design in William Burruss' résumé to determine if they have the minimum qualifications as defined by MGL c 143 § 3.
- b. On a MOTION by Andy Bobola and seconded by John Naff it was unanimously VOTED to grant the request of Kevin J. Flynn (No Affiliation) for approval to take the required exams to become certified as a building code enforcement official. Kevin Flynn meets the minimum qualifications set forth by the BBRS for said position of local inspector and inspector of buildings / building commissioner defined by MGL c 143 § 3 and was granted permission to proceed with the required examination process.
- c. On a MOTION by Dave Fuller and seconded by John Naff it was VOTED to table the request of **Richard Fournier** (City of New Bedford) for approval to take the required exams to become certified as a building code enforcement official. The Committee has requested Richard Fournier to provide more information on his supervisory experience and all-around knowledge of the building code per MGL c 143 § 3. Andy Bobola abstains.
- d. On a MOTION by Dave Fuller and seconded by Michael Clancy it was unanimously VOTED to DENY the request of **Christopher Freitas** (No Affiliation) for approval to take the required exams to become certified as a building code enforcement official. The Committee was unable to find sufficient supervisory experience in building construction or design in Christopher Freitas' résumé to determine if they have the minimum qualifications as defined by MGL c 143 § 3.
- e. On a MOTION by Michael Giampietro and seconded by John Naff it was unanimously VOTED to DENY the request of **Djenald Saint-Louis** (No Affiliation) for approval to take the required exams to become certified as a building code enforcement official. The Examination Approval Form was not notarized and therefore incomplete.
- f. On a MOTION by John Naff and seconded by Dave Fuller it was unanimously VOTED to approve the request of **John Wilkinson** (No Affiliation) for approval to take the required exams to become certified as a building code enforcement official. John Wilkinson meets the minimum qualifications set forth by the BBRS for said position of local inspector defined by MGL c 143 § 3 and was granted permission to proceed with the required examination process.

On a MOTION by John Naff and seconded by Michael Clancy it was unanimously VOTED to acknowledge the *New Employee Report Form* of **Eric Roberts** newly appointed to the position of **Local Inspector** for the **City of Woburn.** Appointed, not yet certified, on March 7, 2022. Twelve-month grace expires March 31, 2023. *NERF signed by Mayor.*
- b. On a MOTION by Michael Giampietro and seconded by Michael Clancy it was VOTED to table the *New Employee Report Form* of **Richard Fournier** newly appointed to the position **Local Inspector** for the **City of New Bedford.** Richard Fournier's qualifications were tabled and will be reviewed again May 3, 2022. Andy Bobola abstains.

- c. On a MOTION Michael Giampietro and seconded by Michael Clancy was unanimously VOTED to acknowledge the *New Employee Report Form* of Louis Allevato newly appointed to the position of Local Inspector for the Town of Sudbury. Appointed, not yet certified, on March 8, 2022. Twelve-month grace period expires March 31, 2023. *NERF signed by Town Manager.*
- d. On a MOTION Michael Giampietro and seconded by Henry Fontaine was unanimously VOTED to acknowledge the *New Employee Report Form* of **Michael Leeds** newly appointed to the position of **Local Inspector** for the **City of Marlborough** on January 10, 2022. *NERF signed by Mayor.*

R7.1.7.4-5 a conditional appointee may petition the Building Official Certification Committee (BOCC) using the Extension Request form for an extension of time to comply with the examination schedule of R7. Upon establishment of cause, the BOCC may grant such an extension of time as it may consider appropriate.

- a) On a MOTION by Michael Clancy and seconded by John Naff it was unanimously VOTED to grant the request of Mauro DiClementi (Town of West Springfield) for a second extension of time to become certified as a local inspector. Said extension shall expire October 31, 2022.
- b) On a MOTION by John Naff and seconded by Michael Clancy it was unanimously VOTED to DENY the request of Jeffrey Fisher (Town of West Tisbury) for a fourth extension of time to become certified as a local inspector.

Per 780 CMR R7.1.7.4.1 Requests for Exam Schedule ... no conditional appointee shall be afforded more than three extensions of time beyond the prescribed period for the level of certification sought.

7. Hearings

a) On a **MOTION** by David Fuller and seconded by John Naff it was unanimously VOTED to take the testimony of **Peter Blanchette (City of Lawrence)** BOCC 4-2022 under advisement and to issue a response at a later date.

On a **MOTION** by Michael Clancy and seconded by John Naff, after further discussion, it was VOTED to recommend to the Board of Building Regulations and Standards to revoke the inspector of buildings / building commissioner certification of **Peter Blanchette** for failure to maintain said certification per 780 CMR R7. Peter currently has 33.5 of the required 45 credit hours. The current training cycle was extended by one year due to the State of Emergency. Committee members expressed great concern an individual could not accumulate the required 45 credit hours in four years. David Fuller and Michael Giampietro opposed.

- b) Hearing for Scott Brazil BOCC 5-2022 was cancelled due to the fact that he no longer works for the Town of Truro.
- c) Hearing for Brian DiBenedetto (City of Worcester) BOCC 6-2022 was cancelled as he acquired the minimum credit hours to make him compliant with his conditional local inspector requirements.
- d) Hearing for George Gambill BOCC 7-2022 was cancelled due to the fact he no longer works for the City of Beverly.
- e) On a MOTION by Michael Giampietro and seconded by Michael Clancy it was unanimously VOTED to recommend to the Board of Building Regulations and Standards to revoke Local Inspector certification of Michael Henry (01-04-1196), BOCC 8-2022, who has *fifteen* credit hours for the training cycle ending December 31, 2020, extended through December 31, 2021 due to State of Emergency. Michael Henry nor a representative appeared for the hearing.
- f) Hearing for Daniel Morin (Town of Chelmsford) BOCC 9-2022 was cancelled as he acquired the minimum credit hours to make him compliant with his conditional local inspector requirements.
- g) On a MOTION by John Naff and seconded by David Fuller it was unanimously VOTED to recommend to the Board of Building Regulations and Standards to revoke Local Inspector certification of Patrick Powell (15-03-1208), BOCC108-2022, who has *twenty-six* credit hours for the training cycle ending December 31, 2020, extended through December 31, 2021 due to State of Emergency. Patrick Powell nor a representative appeared for the hearing.
