**1) Review/Vote- Meeting Minutes for September 2, 2025**

Chair Giampietro introduced September 2, 2025, meeting minutes. John Naff motioned to accept meeting minutes, Andrew Bobola seconded. A roll call vote was held. None opposed, George Peterson abstained. Motion passed with majority with all other members voting yes.

**2) Review/Discuss Executive Director Report**

Executive Director Tammy Gropman reported that of the 13 building officials removed from eligibility in July, five have since been reinstated to active status, and that one other individual had reached out after the September 30<sup>th</sup>, 2025, deadline for the October 7<sup>th</sup>, 2025, BOCC meeting. E.D. Gropman also noted ongoing staff effort to obtain all required annual town clerk reports due by April 1<sup>st</sup> of each calendar year and reminded municipalities of requirement to submit New Employee Report Forms.

**3) Review/Discuss Board Counsel Report**

Board Counsel Charles Kilb stated that he was still awaiting confirmation to provide draft code changes to present to the committee and explained matter of subcommittees considering changes to the 10<sup>th</sup> edition of 780 CMR versus the 11<sup>th</sup> edition.

**4) Hearings**

- a. Scott Holmes BOCC 06-2025 Appeal for September Meeting; Denial of Exam Approval  
Chair Giampietro declared the meeting open. Committee members and Board Counsel introduced themselves. Scott Holmes was present at meeting. Mr. Holmes requested this hearing to appeal the Committee's decision to deny his Exam Approval application at the September meeting. The BOCC cited a lack of five years of supervisory experience for reason of original denial. Mr. Holmes was sworn in, provided brief background of experience, and submitted letter from previous employer. Chair Giampietro read letter to Committee, questioned nature of projects/work performed, and asked whether permits had been pulled under Mr. Holmes CSL. Falmouth Building Commissioner Gary Street provided testimony, stating that Mr. Holmes had been fully vetted and that his experience with structural components over 40 feet in height was advantageous to inspectional services in town. Andrew Bobola motioned to take under advisement, seconded by John Naff. A roll call vote was held, none opposed, none abstained. Motion passed unanimously.
