#### DECISION

GREAT BROOK FARMS INC. D/B/A SLATER'S 356 MAIN STREET BOLTON, MA 01740

LICENSE#: 00010-GP-0112 VIOLATION DATE: 6/08/2022

Great Brook Farms Inc. d/b/a Slater's ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, September 20, 2022, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigator Kujawski's Compliance Check Field Report.

# **FINDINGS OF FACT**

- 1. On Wednesday, June 8, 2022, at approximately 5:07 p.m., Investigators Gould and Kujawski ("Investigators"), inspected the business operation of Great Brook Farms Inc. d/b/a Slater's.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, a Bud Light draft beer for four dollars and eighty-one cents (\$4.81). The underage operative was not asked for identification.
- 3. Bruce Slater, Licensee, appeared at the Commission hearing and testified the underage operative came into the restaurant during a shift change and the server was distracted.

## **CONCLUSION**

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Therefore, the Commission issues a **WARNING.**
